- Form 49** (Companies Act 1965 – List of Directors of the Company) **or Section 14** (Companies Act 2016 – Notification of Appointment of First Secretary), where applicable; and,
- For **sole proprietorship or partnership**, an **Extract of Business Name Registration** shall be submitted.
