- 4. Tenderers shall meet the Mandatory Requirements by submitting the proof of registration, experience and compliance to the minimum qualification requirements as stated below:
 - a) Local Sarawakian Tenderers registered with:
 - i. Pejabat Setiausaha Kewangan Negeri Sarawak (UPKJ) issued by Sarawak State Financial Secretary Office; and
 - ii. Companies Commission of Malaysia (SSM) and/or Registrar of Businesses (ROB) to provide Certified True Copy of the relevant Company Secretarial Documents and/or Registrar of Business/Company; and
 - iii. Construction Industry Development Board (CIDB) Malaysia (Grade 4 and above) [category B with B04, category CE with CE21, category ME with M20 and E11] evidenced by 'Perakuan Pendaftaran Kontraktor' (PPK) and 'Sijil Perolehan Kerja Kerajaan' (SPKK); and
 - b) Minimum paid-up capital Ringgit Malaysia: One Hundred and Fifty Thousand Only (RM150,000.00).
 - c) Average net profit for the last three (3) financial years (2019, 2020 and 2021/2022) shall be positive.
 - d) The Tenderer shall have minimum of three (3) completed similar project within the last seven (7) years (2015-2022);
